## **REVIEW BIDS:**

Bids were reviewed for the purchase of a new truck. Bids for 550, 450 and 350 were reviewed with a total of 16 different quotes to review.

In discussion it was mentioned the Backhoe is also being used to do road inspections. Daniel Netzler made a motion to purchase the 2013 Chevy Silverado 3500 1-Ton Pick-up from Summit Township in the amount of \$25,000.00. Robert Simonelli seconded. Passed by unanimous roll call vote. Carried.

James Sachar made a motion to put the Ford F450 truck and plow with a bad oil pan, broken left front spring and fuel leak out for bid along with the 383 Massey Ferguson with mower listing them As-Is, Where - Is. The Massey Ferguson has a bad clutch, bad brakes and bad transmission. Steven Walker seconded. Passed by unanimous roll call vote. Carried.

The Roadmaster Daniel said he is in need of adding some part time people to the work list for the road crew. Consent was unanimous to go ahead and add more part time people to the work crew if that is what is needed.

Tractor: The Tractor was delivered last week. Joe used it Monday for a couple hours and it broke down. Walsh offered to look at it but it would cost \$2.65/mile plus \$122 an hour to come diagnosis the problem.
