## **OLD BUSINESS:**

The numbers for Recycle Day this year were reviewed. The numbers were higher than last year. There were 1,837 tires collected, 209 freon units, 1085 E-waste and \$1,182 in cash donations. Franklin township had 116 households take part with an overall number of 642 total households.

A discussion on the Employee Handbook and clarifying the "call out policy" was reviewed. Dennis Howard made a motion to amend the Call Out Policy to read Emergency Call-Out Policy. Employees will receive a minimum of two (2) additional hours of pay for any "emergency" or "unexpected" occasion on which they are "called-in" to work in addition to the actual hours worked. This section does <u>not</u> apply to any regularly scheduled hours of work. James Sachar seconded. Passed by unanimous roll call vote. Carried

## **NEW BUSINESS:**

The EMA budget for 2021 was reviewed. Dennis Howard made a motion approving the 2021 EMA Budget in the amount of \$47,050 with a \$1.327 Per Capita for a total to Franklin Township being \$2,166.99. James Sachar seconded. Passed by unanimous roll call vote. Carried
