Dennis Howard made a motion to approve the Edinboro Triathlon to use Fry Road in Franklin Township on Saturday June 3rd, 2023, and to approve Fire Police for that day. Robert Simonelli seconded. Passed by unanimous roll call vote. Carried

Dennis Howard made a motion to decline the proposal from Ford Office Technologies for IT coverage in the amount of \$270.00 a month. Robert Simonelli seconded. Passed by unanimous roll call vote. Carried

Reviewed the quotes from Stephenson and Five Star on new Loader quotes. The current Loader has no brakes and is not a safe piece of equipment.

Stephenson gave a quote for a JCB Model: 427 ZX T4F for 184,335.23 with a trade in value of 8,000 for our current loader with a 2-year warranty.

Five Star presented a quote for a John Deere 2023 Loader 524P Wheel for an amount of \$191,555.69 with a trade in price of 5,000 for our current loader with a 5-year warranty. Kevin Henry stated that their office is only 19 miles from our office, if the machine goes down while it is being worked on, we will get a loaner. The quote is good until the end of the month.

The Supervisors would like to continue to look for a possibly used one as this is more than was anticipated at this time. Ramona was informed to continue with adding the old Loader and Brine Truck on Municibid for next month's meeting.

Resolution 14 of 2022. Reviewed a Small Flow Treatment Facility for Peter and Kathryn Barry located at 11154 Eureka Road, Edinboro. The sewage treatment facility will serve an existing 3-bedroom home, it is intended to replace the failing on-lot septic system located on this parcel.

Dennis Howard made a motion to approve Resolution 14 of 2022 approving the Small Flow Treatment Facility for Peter and Kathryn Barry located at 11154 Eureka Road. Robert Simonelli seconded. Passed by unanimous roll call vote. Carried

Rylie Leicht the current tax collector was informed that due to her new job working with the District Magistrate Denise Stuck she cannot hold an elected position with the township. Rylie Leicht must resign from her position as Tax Collector from the township.

Dennis Howard made a motion to accept Rylie Leicht's resignation as the current Tax Collector in Franklin Township. Robert Simonelli seconded. Passed by unanimous roll call vote. Carried

Dennis Howard made a motion to appoint Zachary Leicht as interim Tax Collector until the next municipal election as per the 2nd Class Township Code, Zachary will be the Tax Collector from now until the first Monday in January of 2024. Robert Simonelli seconded. Passed by unanimous roll call vote. Carried
