The Solar Eclipse is going to be April 8, 2024, and Erie is supposed to be the best place to view it, expected to bring in over 260,000 people. Fairview township is looking at joining the West Erie County EMA, EMA has received a letter of understanding with ADMAR, a 10% discount will be given to each participating municipality along with delivery and pick up fees. Saint Francis is working on becoming an emergency shelter.
