NEW BUSINESS:

Resolution 23 of 2024.

Dennis Howard made a motion to approve Resolution 23 of 2024 to adopt the proposed budget for 2025 as advertised, including the Employee Pay and Benefits Schedule and recommends to the auditors that they set the Supervisor's wages as per the Pay and Benefit Schedule. The balanced budget totals \$751,529.00 (including one-time revenues). Robert Simonelli seconded. Passed by unanimous roll call vote. Carried

Resolution 24 of 2024.

Dennis Howard made a motion to amend the 2024 Budget to reflect the actual revenues received and expenses paid from January 1, 2024, through December 31, 2024, including yearend adjustments made by the Township and/or the auditors. Robert Simonelli seconded. Passed by unanimous roll call vote. Carried

Resolution 25 of 2024.

Dennis Howard made a motion to set the tax levy for 2025 at 3.0 mills; 1.08 mills – General Fund, 0.43 mills – Fire Department Fund, 0.26 mills – Municipal Building Fund, 0.555 mills – Road Machinery Fund, 0.475 mills – Permanent Improvement Fund and EMS Fund 0.200 mills. Robert Simonelli seconded. Passed by unanimous roll call vote. Carried

A discussion on Carbury Road Drainage and culvert project. The township could possibly receive \$180,000 dollars towards the project. The next meeting is scheduled for December 20, 2024, at 2pm at the Blasco Library. Mark Corey is attending with the specific details on all the projects that he is working on for the variety of townships he is representing.

Robet Simonelli made a motion to approve up to \$100.00 for something to be sent to the Part Time Employees wife that just underwent Brain Surgery for a removal of a couple tumors. Dennis Howard seconded. Passed by unanimous roll call vote. Carried
